DINGHY PARK CONDITIONS OF USE – 2018 - (for Members with dinghy spaces)

1. All dinghies must clearly display a current year dinghy park sticker.
2. Only one dinghy per space (no piggy-backing allowed).
3. All dinghies must be of seaworthy condition.
4. Members must keep their space(s) tidy and clear of weeds.
5. Any dinghy should not encroach upon an adjoining space not allocated to them.
6. All concrete paths should be kept clear.
7. Security of all dinghies to be the responsibility of the space-holder.
8. Members must use their dinghy space regularly and not leave it vacant for long periods of time, unless notified to the Membership Secretary – 07944 612435
9. Any dinghy/rack space not paid for by the 31st January in any year, will be reallocated and any dinghy thereon will be removed at the owner's expense.
10. Any transfer of ownership/vacation of space must be notified to the Membership Secretary. Dinghy spaces are not transferable upon sale of any dinghy/craft
11. No flammable liquids are permitted to be stored in the Oar House or Oar House compound.
